DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The main house at Swannanoa is a beautifully situated structure of white Georgia marble in the sixteenth century Italian Renaissance style, reminiscent of the Villa Medici in Rome. The facade of the house is composed of a three-story, five bay center section flanked by two protruding four-story towers. At each corner of the facade is a two-story pavilion, making the whole facade nine bays wide. Filling in the space between the towers is a one-story vaulted arcade which connects at either end with an open gallery continuing around each corner of the facade. As a result of the combination of arcade and galleries, the rooms on the front of the first floor are shaded. The architectural decoration on the whole of the exterior is extremely rich, having a variety of types of window enframements and surface treatment.

The interior of Swannanoa is finely appointed with costly materials. The outstanding feature is a huge Tiffany stained glass window on the landing of the double staircase at one end of the very large central hall. The principal rooms include the Florentine style oak paneled dining room, the gold damasked Louis XV music room, a Persian style office, and an Italian style library. The second floor contains six principal bedrooms, with various dressing rooms and bathrooms.

The terraced Italian style garden at the rear of the house is especially noteworthy. A long pergola across the end of the last terrace separates the formal garden from an informal park, in which is situated a very tall campanile-like water tower.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

Swannanoa was designed by the Richmond architectural firm of Baskervill and Noland as a summer home for the Richmond railroad magnate, Major James Dooley. The house and its gardens, located on the crest of the Blue Ridge Mountains overlooking the Shenandoah and Rockfish Valleys, took several years to construct, and were completed by 1913. After the property passed from the Dooley family in the 1920's, it was made into an exclusive club, and it was during this period that President Calvin Coolidge spent a Thanksgiving holiday there. Swannanoa is now owned by the University of Science and Philosophy, and is maintained as a cultural center and museum of the works of the sculptor, Walter Russell.

In addition to being an important piece of eclectic architecture, the house, in its beautiful setting, is an excellent example of a great summer villa of the Edwardian era. Though generous in conception, Swannanoa is a refined and dignified work, and it remains one of the most complete and thoughtfully handled "Gilded Age" estates in Virginia.

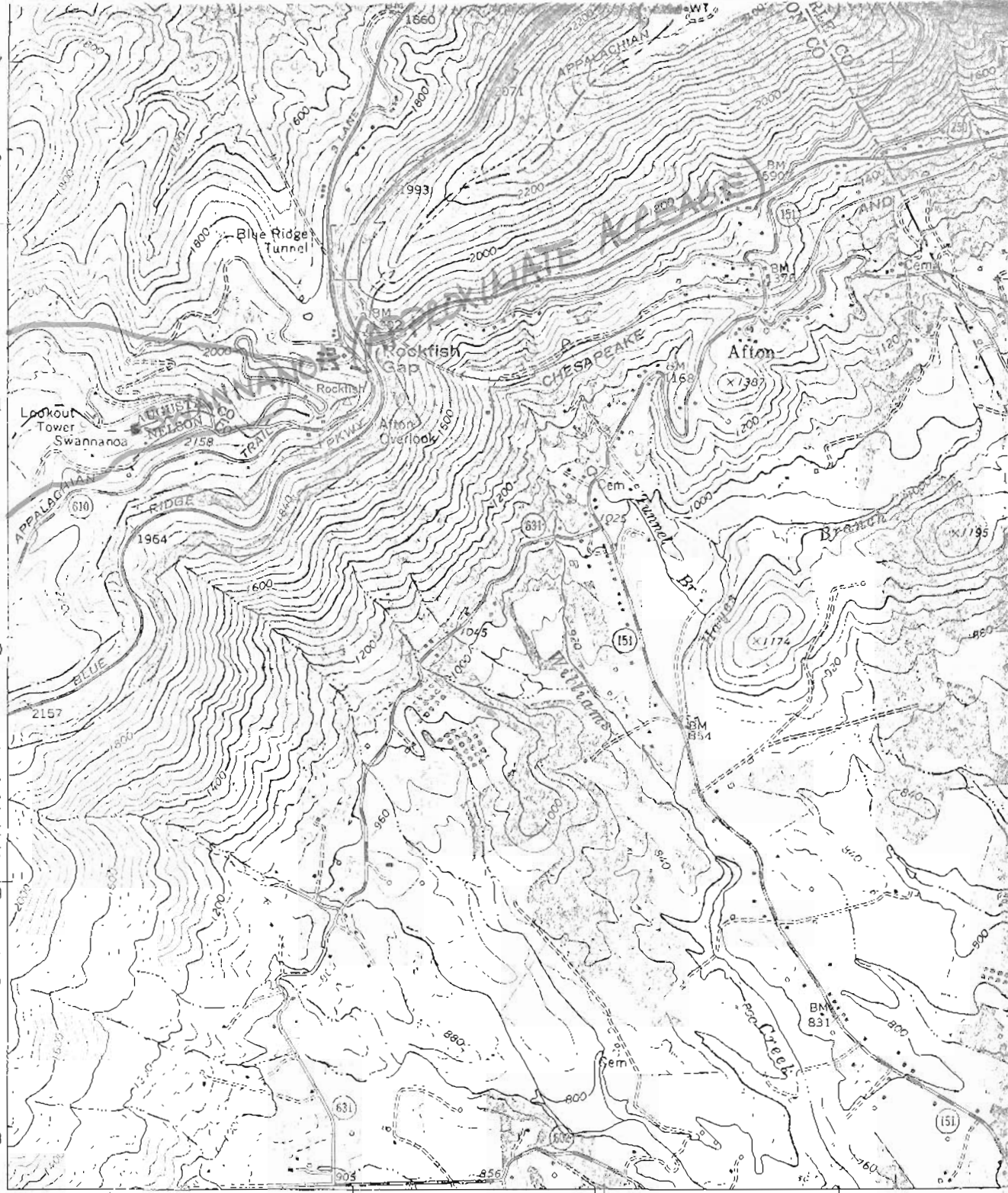

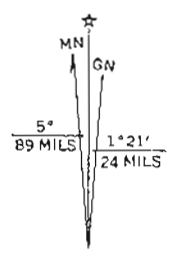
