Spring Hill Baptist church sign at the roadside of route 53. Built for a Black congregation, in the early 1800's. A storage building was added around 2003, along with a small storage unit for the bathroom facilities. Painting and a handicap ramp was also done.

This is a one-story gable sheet-metal roof resting on rubblestone piers infilled with cement blocks. Exterior detailing is minimal. The weatherboards are plain painted white, attached with cut nails and the roof is sheathed in sheet metal. The three-bay lateral facade contains a 2/2 pane sash with glass. The building is white with green trim.

The church was originally established in 1803 out of brush from the woods of Route 53.

HISTORY

Thomas Garland who was the landowner of Buck Island Estates built Spring Hill Baptist Church in 1803 as a worship place for his slaves.

On August 1st, 1808 Thomas Garland willed his entire estate to his housekeeper, Elizabeth Allen, to have and to hold her natural life, and at her death to be equally divided amongst her children; Ellen, Mary, George, Sally, Martha, Malvina, Margaret, James, Clara, Thomas, Alexander, Richard, Edward and her grandson William. All thirteen were biologically Thomas Garland's children.

Thomas Garland and Elizabeth Allen; who was native American Indian, did marry before his death.

On May 11th, 1883, one additional acre of land was transferred from Isaac & Sarah Mildred Thomas to the following Trustees: John Redd, Nelson Smith and David Magruder for \$8.00.

On September 2nd, 1895 Elizabeth Allen and her remaining Children : Ellen Boyd, Margaret Cross, Mary Barbour, Clara James, James Garland, Richard Garland and Alexander Garland transferred the one acre of property where the church stands, to the Trustee Board: Milton White, Nelson Green and Jerry Barbour. A fee of \$1.75 was paid for this transfer. On June 10th, 1949 an additional acre was presented to Spring Hill Baptist Church Trustee board: Lindsay Jones Jr., Henry Green & David Winston II as a gift, by Betsy Lightfoot, a widow and Irving Whiting, unmarried. A fee of \$2.00 was paid for this Transfer.


