Fox Hall is located on the northeast side of Norfolk. The property is on Halstead Ave., approximately 500 feet south of East Princess Anne Road (a historical thoroughfare from Norfolk to Princess Anne County). The Fox Hall tract originally extended further south to the Eastern Branch of the Elizabeth River. It is sited on land formerly in Norfolk County that was later annexed by the City of Norfolk.

Fox Hall is a private dwelling that has been continually occupied for nearly 300 years. It is the oldest house remaining in Norfolk. Fox Hall is a brick structure laid on the north and south elevations in Flemish bond and in Flemish and English bonds on the east and west ends. A two-story frame addition was added on the southwest side in the late 19th-early 20th centuries by John L. Roper. A five-year, strictly evidence-based restoration has recently been completed of Fox Hall, inside and out.

Ann Thelaball inherited the property upon which Fox Hall sits from the estate of her father, James Thelaball. Her brother, Francis Thelaball and his son, built a similar, but smaller house, now known as the Lynnhaven House in adjoining Princess Anne County (now Virginia Beach). There are two additional brick houses in nearby Virginia Beach that are related to Fox Hall and Lynnhaven House. They are Thoroughgood House and Weblin Place.

There are too many brickwork and construction similarities among Lynnhaven House, Thoroughgood House, Weblin Place, and Fox Hall to be coincidences. The same undertaker must have been involved in the construction of all of these houses in the circa 1720-30 timeframe.

While Fox Hall was initially conceived with a hall-kitchen floorplan like Lynnhaven House, it was actually constructed with a hall-central passage-kitchen floorplan. This was not a later alteration but a change order during early construction. Evidence for this change is in the floor framing, flooring, plaster lath, and in the asymmetrical placement of the front and rear doors hard against the passage-hall wall.

The most notable interior features of Fox Hall are the large hall and kitchen fireplaces.

Across the front of the house on the north side below the kick eave and above the door and windows, there is decorative "hounds tooth" brickwork, a rare feature in Virginia architecture.

The owner of Fox Hall at the time of construction was Ann Thelaball, who married James Lowery and later married William Ivy. The Fox Hall property subsequently passed through ownership of numerous Norfolk notables including: Thomas Talbot, Elizabeth Boush, Alexander Tunstall, Moses Myers II, Henry Van Wyck, Josiah Porter, J. H. Cofer, and John L. Roper.


