## State Review Board (SRB)

Chair Mullen called the State Review Board to order at 9:30 a.m. Deputy Director Williams took roll call of SRB members to confirm the presence of a quorum. Ms. Shull, Vice-Chair Allen, Dr. Breen, Dr. Smith, Mr. Rutledge, and Chair Mullen are present.

Chair Mullen read the land acknowledgement statement. He next explained the purpose and duties of the SRB and the process of Register designation. Each SRB member introduced themselves.

Chair Mullen noted that today's meeting is taking place in person and online, and that it is being recorded. He said that some members of the public are attending the meeting online. He thanked Lynn Swann, general manager of the Omni Homestead Resort, and the hotel staff for their hospitality. He also thanked Lee Elliott of Preservation Bath for her help hosting the meeting.

Chair Mullen next asked the SRB members if there were any questions about the agenda. Hearing none, Chair Mullen requested a motion to approve the meeting format and agenda. Ms. Shull so moved, and Dr. Smith seconded. The Board members voted unanimously in the affirmative. Chair Mullen asked for a motion to approve the June 20, 2024, meeting minutes. Mr. Rutledge so moved, and Ms. Shull seconded. The Board members voted unanimously in the affirmative.

Chair Mullen asked for a motion to approve the revised electronic meeting policy. Mr. Rutledge so moved, and Dr. Breen seconded. The Board members voted unanimously in the affirmative.

Chair Mullen asked for a motion to approve the 2025 meeting schedule. Vice-Chair Allen so moved, and Dr. Breen seconded. The Board members voted unanimously in the affirmative.

### **Board of Historic Resources (BHR)**

Director Langan called the Board of Historic Resources to order at 9:39 a.m. She noted that the Board is currently without a chair or vice-chair. Deputy Director Williams took roll call of BHR members to establish the presence of a quorum: Ms. Jorjani, Dr. Spivey, Mr. Pollard, and Mr. Townes are present. Mr. Bosket is attending virtually.

Director Langan requested a motion to approve Mr. Bosket's virtual attendance. His presence will not count toward a quorum, but he can vote on matters presented. Dr. Spivey so moved, and Mr. Pollard seconded. The Board members voted unanimously in the affirmative.

Director Langan requested a motion to nominate a new chair and vice-chair of the Board. Dr. Spivey moved to elect Ms. Jorjani as chair and Dr. Rutherford as vice-chair. Mr. Pollard seconded. The Board members voted unanimously to elect Ms. Jorjani as chair and Dr. Rutherford as vice-chair.

Chair Jorjani next explained the purpose and duties of the BHR. She invited BHR members to introduce themselves and introduced herself. Chair Jorjani noted that today's meeting is taking place in person and online and is being recorded. She said that some DHR staff members are attending the meeting online as are members of the public.

Chair Jorjani requested a motion for approval of the meeting format and agenda. Mr. Pollard so moved, and Dr. Spivey seconded. The Board members voted unanimously in the affirmative. Chair Jorjani asked for a motion to approve the June 20, 2024, meeting minutes. Dr. Spivey made the motion and Mr. Townes seconded. The Board members voted unanimously in the affirmative.

Chair Jorjani asked for a motion to approve the revised electronic meeting policy. Mr. Pollard so moved, and Dr. Spivey seconded. The Board members voted unanimously in the affirmative.

Chair Jorjani asked for a motion to approve the 2025 meeting schedule. Dr. Spivey so moved, and Mr. Townes seconded. The Board members voted unanimously in the affirmative.

### **Welcome**

Director Langan invited Ms. Lee Elliott, President of Preservation Bath, to speak. Ms. Elliot welcomed the Boards, and briefly explained the history of Preservation Bath, which was born out of concern for the Warm Springs Bathhouses and worked to generate public focus on the importance of the buildings and the need for their preservation. Ms. Elliot discussed the group's accomplishments and continuing focus on preservation projects in

Bath County, which include the development of preservation guidelines and design criteria for maintaining local architectural standards, facilitating the survey and nomination of the Warm Springs and West Warm Springs Historic District (VLR, NRHP 2018), and driving ongoing efforts to survey and nominate the proposed Bacova Historic District. She noted the group's recent focus on country churches, including efforts to rehabilitate and preserve the John Wesley Methodist Episcopal Church (VLR, NRHP 2013), a significant resource within the local African American community in West Warm Springs. Finally, Ms. Elliot noted the organization's hopes of preserving the original 1920s airport terminal at the Ingalls Field Airport.

Director Langan then invited Ms. Lynn Swann, Director of Marketing and Communications at The Omni Homestead, to speak. Ms. Swann welcomed the Boards and spoke about the importance of the Homestead restoration and the integral role of DHR's historic rehabilitation tax credit program. She noted that the grand reopening of the resort in October 2023 generated feature stories in several major media publications, as well as recent articles about the restoration of the Warm Springs Bathhouses. Ms. Swann acknowledged Director Langan's key role in advising and facilitating the restoration, and listed numerous awards and accolades received for the architectural restoration of both the Homestead and the Warm Springs Bathhouses.

### **Director's Report:**

Chair Jorjani introduced Director Langan.

Director Langan began her report by acknowledging the important role that Ms. Shull and Mr. Jody Lahendro played as members of the advisory council for the restoration of the Warm Springs Bathhouses. She then welcomed the two newly appointed members of the Board of Historic Resources: Dr. Ashley Spivey, who has previously served two terms on the board, and Mr. Jamie Bosket, president of the Virginia Museum of History and Culture. Director Langan also introduced Andrew Tarne from the Office of the Attorney General. She extended her thanks to the leadership and staff of the Homestead for hosting, welcoming, and extending such hospitality to the Boards and to DHR staff. She thanked Preservation Bath for their ongoing work and noted her anticipation for the deserved recognition of the Bacova Historic District. Director Langan then thanked Cornelia and Will Hodges, owners of Troddenvale at Oakley Farm, for hosting the dinner and reception for the Boards as well as for their excellent stewardship of a DHR easement property. She thanked W. Tucker Lemon, previous Vice-Chair of the Board of Historic Resources, for his generosity in hosting and continued commitment to preservation. Finally, Director Langan thanked DHR staff for their hard work in preparing for today's meeting.

Director Langan next provided several DHR staff updates. She introduced Austin Walker, National Register Program Manager, and shared that Joanna McKnight has taken over as Eastern Region Architectural Historian, inheriting the role from the recently retired Marc Wagner. She informed the Boards that Allison Mueller has begun work as DHR's Chief Curator, with Serena Soterakopoulos moving into a supporting role in Collections, and that DHR's new Chief Financial Officer, Connor Hudgins, will be starting in September. She then offered an update on ongoing recruitment efforts, noting that interviews for a Review and Compliance Architectural Historian are underway and those for a Deputy Director of Preservation Programs are upcoming in early October. She further noted that the department's NAGRA Coordinator position is currently under a second round of recruitment, while a new Grants Coordinator position to manage the Virginia 250 Preservation Fund will open soon.

Director Langan spoke briefly about the upcoming General Assembly Session, stating that DHR has put forward requests that include increased funding for general operations. She also noted that non-profit organization Virginia Forever is requesting an increase in funding for DHR's BIPOC Historic Preservation Grant Program.

Director Langan went to highlight the fact that DHR is currently administering more grants than ever before, including numerous National Park Service grants, General Assembly passthrough grants, and the recurring Cost Share, Certified Local Government, Threatened Sites, and BIPOC Grant Programs. She applauded Amanda Terrell's second successful application for the Paul Bruhn Historic Revitalization Grants Program, which will see an additional \$750,000 awarded for preservation projects in Southwest Virginia. She further noted that DHR received 227 preapplications for the Virginia 250 Preservation Fund, with a total ask of \$137 million. Successful

pre-applicants have been invited to submit a full application and will be competing for \$20 million in available funding.

Director Langan then spoke briefly about DHR's planning for the Virginia 250 Commemoration. A major priority will be improving the quality of early nominations for key properties on the Virginia Landmarks Register and National Register of Historic Places, which often lack the level of intensive documentation required today. She further noted that DHR will be prioritizing the conservation of artifacts in collections that will be loaned out as part of Virginia 250 celebrations. DHR will also be partnering with the Virginia Museum of History and Culture on an exhibit related to the commemoration.

To conclude, Director Langan noted the lack of a Burial Permits update at today's meeting from Joanna Wilson Green, who is attending the Sovereign Nations of Virginia Conference along with other DHR staff. She cited the conference's focus on the role of state agencies in tribal outreach and consultation as a key priority for DHR.

### **Public Comment**

Chair Jorjani introduced and explained the purpose of the public comment period and noted that speakers are asked to limit their remarks to three minutes. She added that the BHR will not take action on any comments presented today but DHR will take the comments under consideration. She requested that speakers limit their comments to a span of three minutes. She added that a second comment period will occur when the BHR meets this afternoon to review Highway Marker and Easement program materials.

No one has signed in to speak in person; four persons attending virtually registered to speak, though only two were in attendance during the public comment period:

1. Willie Greene, Mayor of the City of Galax, spoke in support of the nomination for the Rosenwald-Felts School, of which he is an alumnus.
2. Alyson Ramsey and Eric Proebsting of Thomas Jefferson's Poplar Forest spoke in support of the updated and amended National Register documentation for the property, which was first recognized in 1969, and noted the contributing authors to the nomination.

Deputy Director Williams thanked everyone who spoke today, noted that their comments will receive careful consideration, and said that the public comment period is concluded.

Deputy Director Williams called for a brief break at 10:28 a.m. The meeting resumed at 10:37 a.m.

## **Western Region**

Mr. Pulice presented the first nomination, an update to the 1969 National Register documentation for Thomas Jefferson's Poplar Forest. The updated nomination includes a full inventory of resources on the property and involves the addition of new criteria and areas of significance, clarification of the period of significance, and adjustments to the property's originally listed boundary.

Ms. Shull expressed concern over the proposed boundary revisions, which she felt were not sufficiently justified per the requirements of the National Register regulations. She recommended additional information be provided justifying the proposed boundary increase and decrease areas as well as consultation with the National Park Service regarding potential amendments to the National Historic Landmark boundaries for Poplar Forest.

Mr. Pollard and others noted the otherwise excellent work completed as part of the nomination update as well as the clear need for similar updates to the documentation of many of Virginia's earliest and most important listed sites.

Ms. Shull moved that the nomination be reconsidered once further work related to the boundary revisions has been completed. Dr. Allen seconded. The Board members voted unanimously to reconsider the nomination at the December meeting.

Ms. Jorjani asked for motion to reconsider the nomination following the completion of further work related to the boundary changes. Dr. Spivey so moved, and Mr. Pollard seconded. The Board members voted unanimously to reconsider the nomination at the December meeting.

**CALL TO ORDER**

Chair Jorjani called the meeting to order at 12:58 p.m.

Chair Jorjani read the Board of Historic Resources Call to Order and invited those Board members present to introduce themselves: Mr. Pollard, Dr. Spivey, Mr. Townes, Mr. Bosket and Chair Jorjani.

Chair Jorjani read the following BHR Purpose Statement:

*The Virginia Board of Historic Resources is an official policy-making board of the Commonwealth of Virginia created by the Code of Virginia. Its policies are implemented by the Department of Historic Resources, which day in and day out labors on behalf of our irreplaceable resources in the interest of the citizens of this Commonwealth. The Board is charged primarily with the responsibility for:*

1. *Designating historic landmarks of local, statewide, or national significance;*
2. *Establishing historic preservation practices for the care and management of our Virginia Historic Landmarks;*
3. *Designating state-recognized historic districts and archaeological sites and zones;*
4. *Approving historical highway markers;*
5. *Reviewing programs and services of the Agency, and making recommendations to the Director of DHR and the Governor regarding programs and services; and in order to preserve important sites and buildings in perpetuity; and*
6. *Accepting voluntarily granted gifts of preservation easements over historic properties to the Commonwealth.*

*The Governor of Virginia selects members of the Board from volunteer and professional leaders of Virginia's history, preservation, and museum communities. Votes taken during this meeting are official actions of the Commonwealth of Virginia Board of Historic Resources.*

Chair Jorjani asked for a motion to approve the current BHR Meeting Agenda. With a motion to approve the September 19, 2024 BHR Meeting Agenda by Dr. Spivey and a second from Mr. Townes, all members voted in the affirmative.

Chair Jorjani reminded everyone that this is a public meeting that is being streamed online. The online feed is being recorded. Chair Jorjani thanked The Omni Homestead Resort and Bath Preservation for hosting this meeting.

Board Comments Summary: With regards to the public comments for and against the “Black Exodus From Gwynn’s Island” highway marker, Board members noted the lack of consensus for the marker. Board members also noted that this particular marker has gone through extensive review, and it meets the statutory requirements. Board members encouraged the submission of additional highway marker applications representing other aspects Gwynn’s Island’s history. Finally, in response to public comments in opposition to the marker, it was noted that economic opportunities were not the only thing that caused movement of African American populations. Jim Crow segregation and the eugenics movement also played large roles in the migration of minority populations.

With a motion to approve New Markers #1-9 by Dr. Spivey and a second from Mr. Pollard, all members voted in the affirmative.

Other Board Members noted that the battlefield park development is a very complicated process. Ms. Musumeci confirmed the complexity of this project but noted that the various nonprofits and state agencies have a good road map going forward following the successful completion of Phase I earlier this year.

- Provision 1: *...Thereafter, the Town House will be maintained and preserved in its documented state as nearly as practicable, though structural changes, alternation or addition or improvements as would not in the opinion of the Grantee fundamentally alter the architectural significance or historic character of the house and its setting may be made thereto by the owner provided that the prior written approval of the Grantee, Virginia Historic Landmarks Board to such change, alternation, addition or improvement shall be obtained.*
- Provision 2: *...After this Deed of Easement, no building or other structure described herein shall be constructed, altered restored, renovated or extended on the Easement Property except in a way that would be in the opinion of the Grantees be in keeping with the historic character of the Town House and its setting, and provided that the prior written approval of the Grantee Virginia Historic Landmarks Board to such action shall be been obtained.*
- Provision 3: *...No archaeological features on the Easement Property shall be disturbed or excavated without having been surveyed by an archaeologist approved by the Grantee Virginia Historic Landmarks Board A copy of any archaeological report on features on the Easement Property shall be given to the Grantees.*

##### Easement Violation: Remediation

Property owners have agreed to commission an Historic Structures Report documenting the history and evolution of the Town House since its construction.

Board Comments Summary: Board members expressed surprise that this property was not flagged by the City of Alexandria as an easement property. Board members also asked about any archaeological implications resulting from this project. Mr. McDonald noted that the owners are planning a new patio area and adding planter beds to the yard.

DHR will recommend that the owners consult with Alexandria Archaeology to determine if there are any archaeological resources in these areas. DHR may require evidence of consultation with the city for this project.

### **Regulations Concerning the Contextualization of Monuments or Memorials for Certain War Veterans**

Ms. Spota presented to the Board for final approval the proposed regulations concerning the contextualization of monuments or memorials for certain war veterans:

The Board shall evaluate the applications and approve them based on the following considerations:

- (i) whether the proposed marker contains true and correct contextualization text,
- (ii) whether the proposed contextualization text provides a complete and accurate historical context,
- (iii) the quality and validity of the documented sources and the documented research provided,
- (iv) whether the proposed design is sufficiently distinct from state historical markers, and
- (v) the appropriateness of the proposed location of the marker.

In addition to new markers, any changes to an existing marker would also have to be approved by the Board. If the Board approves certain contextualization text and the local government wants to make changes, those changes will also have to be approved by the Board.

The proposed regulation would also prohibit any other contextualization text produced on or near a monument or memorial on anything other than a marker approved by the board and would require the local government to remove any such unauthorized contextualization text.

Board Comments Summary: None.

With a motion to approve and adopt the final language of the Regulations Concerning the Contextualization of Monuments or Memorials for Certain War Veterans as presented by staff by Mr. Pollard and a second by Dr. Spivey, all members voted in the affirmative.

[Although not given the opportunity during the meeting, Mr. Bosket did abstain from this vote.]

The regulations will now be reviewed by the Department of Planning and Budget and the Governor's Office for their final approval. The regulations are expected to go into effect later this fall.

Amanda Davis of the NYC LGBT Historic Sites Project spoke briefly in support of the PIF for the Tony Segura and Marsh Harris House, which she co-authored with DHR’s Blake McDonald. The Tony Segura and Marsh Harris House represents the first property in Virginia evaluated and determined individually eligible based on significant associations with LGBTQ history and activism.

The SRB members approved all the PIFs on the Consent Agenda by voice vote.
